## IV. Treasure's Budget Report - Jone Burr

- 1. Two things are going to change in the Proposed Budget: 1) Insurance 2) Contingencies.
- 2. We expected a 100% increase for instance, it was \$791,000
  - 1. Bob Mitchel did a good job researching the market.
- 3. Our increase came to 30% and we stayed with the same company, American Coastal.
- 4. The base is: \$491,000, Documents and stamps \$1,600, Finance \$20,657

- 5. In July we have to do an evaluation study for next year and insurance will probably go up again.
- 6. Legally we are required to do it every 3 years.
- 7. New Total: \$517,577, an increase of 45%
- 8. You have seen in the newsletter, that we have been over budget every single month.
- 9. What was a contingency budget of \$50,000, we will increase that to \$100,000 because we are \$100,000 in the hole for the year. Rather than do a Special Assessment. Next year it should be where it needs to be.
- 10. 1/1 will increase by \$56.56, 2/2 by \$73.30, 2/1 by 68.30 and 2/1 Special by \$68.89
- 11. Still better than last year because we had a Special Assessment and we are not planning on having one this year if we don't have to.

Cheryl made a motion to approve the budget as proposed, and Doug seconded it, all in favor. Motion passed.

Jack remarks: We will go over past Special Assessments and expenditures. He made a motion to adjourn the meeting, and Doug seconded it, all in favor. Motion passed.
