FINANCE REPORT - JOE BOOTH

IMPORTANT THAT YOU GET YOUR PROXY INTO THE OFFICE FOR THE MEETING ON MARCH 5TH. ANY QUESTIONS PLEASE CONTACT THE OFFICE.

I am pleased to report to you for the period ending 1/31/19. As this is the first month of the year it is relatively uneventful. Under budget for this period and year to date by \$1600.

By now you are aware that we will have an assessment to cover roof replacement. You should have received your notices in the mail and had the opportunity to attend the special meeting.

There is no coupon book issued as this is a onetime payment. All notices were sent to your mailing address of record with Ameritech. It is vital that you keep your mailing address of record current with Ameritech for official and legal mailings. Any change must be given to them in writing. We can assist you in the office.

We are in the process of collecting delinquencies from the last assessment. Failure to pay this current assessment in the time allowed will require us to hand the collection over to our attorney. So please make your payment on time. If you have any questions, please call the office.

Please keep in mind that if we did not prudently fund our roof reserves as we have, we would have to assess for the total \$577,800. As it is, we will only have to assess for the \$77,800 interest and administrative costs because we have enough in reserves to pay for the principle on the loan. If we had to assess for the entire loan it would be an average of \$1,211 a door.

As we have stated over the years...it is the inevitable cost of living in a condo community. We have been fortunate over the years where we have not had to burden the homeowners with high assessments. We cannot predict if and when that will happen. But we all own a share of this Association and Community and as such we have the responsibility to maintain it.

Leash law

(Ord. No. 17-07, § 1, 2-21-17)

Sec. 14-63. - Dogs or cats at-large.

- (a) No dog or cat shall run at-large within the county, as defined under this article. Any person who possesses, harbors, keeps, or has control or custody of any dog or cat which is running at-large shall be in violation of this article, regardless of the knowledge, intent or culpability of the owner.
- (b) This section shall not apply to police dogs as defined in F.S. § 843.19, as may be amended, when such dogs are engaged by a law enforcement agency in an official capacity, or to any dog which is actually engaged in or being trained for the sport of hunting during a legal hunting season within authorized areas and supervised by the owner.
- (c) The owner of any female dog or cat in heat (estrus) which is not kept confined in a secure enclosure, such as a building, veterinary hospital, boarding kennel or closed kennel, such that the female dog or cat cannot come in contact with any male dog or cat, except when the owners of both animals intend to breed such animals, shall be deemed in violation of this article. A fenced area is not sufficient enclosure for the purpose and intent of this subsection.

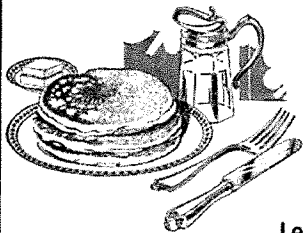

Make sure both the AT and Mission Hills offices have your correct mailing address!

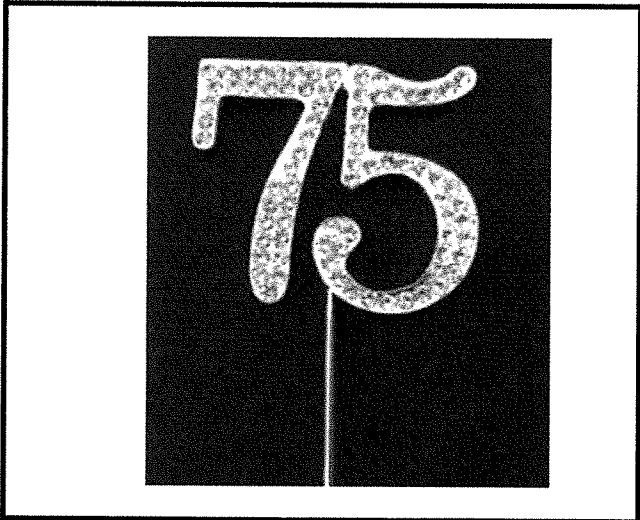
The correction must be in writing or by email. Forms are available in our office & in your coupon book.

Law of the Land
THIS AMENDMENT TO THE DECLARATION
WAS CERTIFIED ON NOVEMBER 14TH, 1999

ARTICLE XVII – PARKING

All parking spaces and/or areas not identified by number and letter, thereby constituting Limited Common Elements as herein before provided, shall be used in common by the unit owners, their guests and invitees pursuant to reasonable rules and regulations to be adopted from time to time by the Association. Unit owners, their guests and invitees may not park in any parking space assigned to another unit owner without the written permission of such owner. The written permission must be on file in the Association office. Unit owners are limited to no more than two (2) vehicles per unit to be parked on condominium property unless prior permission has been granted by the Board of Directors. No motorcycles, motor homes, campers, trailers or other recreational vehicles of any kind shall be parked on the condo- minimum property at any time; provided however, that, if the owner or operator of such vehicle shall first obtain approval in writing from the Association, the vehicle may be parked on the condominium property in a location at the clubhouse designated by the Association for such parking for a period not exceeding forty-eight (48) hours. No vehicles of any kind may be parked on a street within the condominium property where a sign is posted prohibiting parking. Boats, jet skis and other watercraft, and trailers for such watercraft, may not be brought onto or parked, either temporarily or permanently on the condominium property. No trucks whose registered curb weight is greater than three-quarter (3/4) ton or which is used for commercial purposes may be brought onto or parked, either temporarily or permanently, on the condominium property; provided, however, that trucks used by service contractors having business with a unit owner may be parked temporarily on the condominium property but only while that contractor is actively performing service for the unit owner. No person may bring onto or keep on the condominium property a vehicle of any kind that is then inoperative, or that does not then have a current registration and license plate. All vehicles must obey all posted parking signs including, but not limited to, alternate side of the street parking requirements, and parking in the direction of traffic flow. If any vehicle is parked in a location on the condominium property in violation of this Article, such vehicle shall be considered parked in an unauthorized location contemplated by Chapter 715, Florida Statutes, and the Association shall have the authority to cause the offending vehicle to be towed from the condominium property as provided by that chapter.

NANA BLAKE'S IRISH POTATO CANDY

Enjoy this treat from my Irish/Catholic neighborhood in SW Philly. Me "granmither" made these every St. Paddy's Day in memory of the Great Potato Famine.

INGREDIENTS:

- ¼ cup mashed potato (medium size .. bake in microwave .. scoop out potato and mash
- ½ teaspoon of salt
- 3-1/2 cups sifted confectioners sugar
- 1 teaspoon of vanilla extract
- 1 cup of shredded coconut (optional)
- 1 tablespoon of butter

cinnamon (or powdered chocolate)

DIRECTIONS:

- place mashed potato in a large bowl
- add salt, sugar, vanilla extract, coconut and butter
- mix well
- knead several minutes, adding more sugar to make a stiff dough
- tear off a teaspoon of dough and form into a small marble-sized ball
- roll in cinnamon (or powdered chocolate)
- lay on waxed paper for about 1 hour to dry

store in airtight container
